### DISTRICT WISE ACTIVITIES



### Ri-Bhoi



DPM and Assistant Manager (KM) inspected a training program being conducted by Mr. Stephan Shadap, an innovator under Grassroon Innovation Fund. The training focused on crafting of beehives from straw and bamboo, valuable for beekeeping and ecological sustainability.

Beekeeping enhances biodiversity, pollination, honey production, and local income. The training aimed to equip participants with skills for making beehives from locally available, sustainable materials.

Mr. Stephen Shadap also discussed the proposed activities during the training program. The ongoing Bee-Museum cum Training Centre construction underscores Ri-Bhoi DPMU's commitment to beekeeping and knowledge sharing. This center can serve as a hub for training, exhibitions, and conservation awareness.

With the Spring Chamber in place, Mawpun Village can now look forward to increased water availability and a more sustainable approach to water resource management, which will benefit local residents and contribute to the region's overall development.



### East Khasi Hills







On August 3rd and 4th, 2023, the KM teams from SMPU and DPMU visited Mawlyngngot village in Mawkynrew Block to meet with Executive Committee Members for a site inspection of the various interventions implemented in the village for video documentation.

### **DISTRICT WISE ACTIVITIES**





On August 3, 2023, a team comprising Training Specialists, Environmental Management and GIS, along with two Village Community Facilitators (VCFs) and the Sordar, visited Synnei Village in Mawsynram Block to initiate the Forest Management Plan (FMP) enumeration process. The total forest area to be surveyed is 172.98 hectares. Given the steep topography and dense forest cover, it is anticipated that the FMP exercise will require approximately 10 days for completion. The Community Forest has been nominated for Payment for Ecosystem Services (PES) as part of the Green Meghalaya initiative, and the forest has been found to be thriving and untouched.





On August 9, 2023, Knowledge Management (KM) team visited Mawlyngot village, located within the Mawkynrew Block, to conduct video documentation of a check dam.

### DISTRICT WISE ACTIVITIES



### **North Garo Hills**





Agroforestry efforts in Damit Dangra, led by VNRMC under Resubelpara C&RD Block, involved planting pineapple, papaya, and orange saplings on community land in 2021. Now, with these trees bearing fruit, the community can both consume and sell them, raising funds for ongoing sustainable development. The generated funds will be used to purchase more saplings, expanding the agroforestry plantation. This expansion will enhance the ecosystem, biodiversity, and environment of the area while promoting economic stability.





The boundary demarcation carried out by the DPMU team members at Asim Apal village under Kharkutta C&RD Block on August 3, 2023, signifies a proactive move towards improved land management and conservation. This demarcation provides clarity to villagers and local authorities regarding the boundaries of the reserve forest, vital for its protection and sustainable use. The benefits of boundary demarcation extend to both the environment and community, enhancing biodiversity support, water regulation, and soil conservation.

The utilization of the PES grant underscores the importance of encouraging community engagement in environmental preservation, potentially yielding far-reaching positive effects on the ecosystem and villagers' well-being.

### State Level Workshop on Agroecology Learning Circles (ALC) and Natural Resource Management co-organized by NESFAS and MBMA

A two day State Level Workshop on Agroecology Learning Circles (ALC) and Natural Resource Management approaches concluded on August 9, 2023 on the occasion of International Day of the World's Indigenous Peoples at the State Central Library, Shillong. Shri Gunanka DB, IFS, Additional Project Director, MCLLMP, graced the occasion as the Chief Guest. Custodian farmers and representatives from more than 100 partner villages, like-minded organisations and various officials attended the two-day workshop on August 8 and 9, 2023 co-organized by NESFAS and MBMA in partnership with SURE, SSC.





The event witnessed community-led sharing of best practices and peer learning based on traditional farming methods and management of soil, pests, and seeds and also covered various topics such as Forest Management Plan, Payment for Ecosystem Services, Water Resource Management, Living Root Bridges etc. During these sessions, custodian farmers



and subject experts shared their experiences and testimonials which enhanced further learning and knowledge-sharing. The event also launched two relevant documents, namely the Community Seed Bank Catalogue and a booklet on Natural Pest Management.

The workshop aimed to create and strengthen partnerships between different stakeholders, celebrate the achievements of grassroots innovators and recognize the contribution of traditional knowledge holders.

The workshop also included an exhibition which showcased a variety of local seeds, biopesticides, biodiversity-based Midday meals initiatives and NRM practices implemented across communities. This was done to provide a platform for different stakeholders to come together and share and disseminate rich and unique traditional knowledge and information and the diversity of Indigenous Peoples' Food Systems in the state.

Speaking on the occasion, Mr. DB Gunanka congratulated the efforts of NESFAS, its partner communities and CLLMP for the successful implementation of the ALC project, and also drew similarities between Meghalaya and his home state of Karnataka, as both being staple consumers of millet which gradually shifted to rice. Addressing the audience, he said, "We need to maintain and strengthen our rapport with the community so that the project does not end here. We need to keep the movement alive".



Resonating on the same note, Mr. Pius Ranee, Executive Director, NESFAS, highlighted that ALC has also become a creative and collective space where community members and experts meet to share and learn from each other on how to enhance local agroecology practices, food sovereignty and social transformation through local food initiatives. The project "Empowering indigenous communities through Agroecology Learning Circles (ALCs) for resilient, integrated and innovative natural resource management", funded by the World Bank and supported by Meghalaya Basin Management Agency (MBMA) under the innovation fund has enabled NESFAS and its partners to establish and consolidate 100 ALCs across Meghalaya.







The workshop concluded with a closing ceremony whereby Dr. Dhrupad Choudhury, Adviser, NESFAS, congratulated NESFAS and MBMA for organizing the workshop and reflected on the need for continuity, and the need to set up for knowledge network to share issues to co-learn and co-create solutions. He highlighted that MBMA is well-placed to support the setting up of knowledge networks with different peers and urged them to work on the same.





Mrs. Otilia Mukhim, a custodian farmer from Jatah Lakadong, shared her thoughts on behalf of her fellow farmers and thanked MBMA for giving opportunities to them to have a common ground for knowledge-sharing. "We have received a lot of information from the two-day workshop. There is a need for the conservation of forests and water resources and we must strengthen our food systems for a sustainable future. We wish to carry this knowledge further as ALC members through SHGs and awareness programmes, especially for the youth since we need to showcase our traditional food systems to the world", she was quoted as saying.

The closing ceremony concluded with a rendition performed by ALC musical members of Khliehumstem and an entertaining couplet performed by Mr. Nestar Kharmawphlang, Chairperson of NESFAS. Thus, the fruitful workshop came to an end on a promising note for a better, food-secure, self-sufficient tomorrow with farmers taking the lead with their enriched knowledge and renewed dedication.



The DPMU EKH TEAM visited Laitmynsang Village on August 4th, 2023. The village is situated in the Mawkynrew Block and was accompanied by members of Asian Confluence. The primary purpose of this visit was to gain a deeper understanding and acquire firsthand information from the communities about the implementation process of Payment for Ecosystem Services (PES). During the visit, a discussion took place between the Asian Confluence members and the communities, during which the following points were highlighted:

- 1. The communities possess a forest cover of over 40 hectares, which has been included in the PES program.
- 2. Various activities have been undertaken as part of the PES initiative, including Fireline Control, Plantation, Demarcation, and installation of signboards.
- 3. The community expressed that the inclusion of PES in their community has been a blessing.

In the course of discussing income generation activities and livelihood issues, the following activities were mentioned:

- a. Livestock rearing
- b. Mushroom cultivation
- c. Fish farming



On August 8, 2023, MegLIFE consultants, Mr. Gautam Chakravarti and Dr. Reddy, visited Balupara village with the aim of identifying a farmer and a suitable piece of land for conducting experimental research on cotton. Mr. Rasen Sangma, the President of MegLIFE Balupara VPIC, generously offered his land for this project. Approximately forty years ago, cotton cultivation flourished in Garo Hills, even amid the practice of shifting cultivation. Its renown emanated from trade routes through Bangladesh prior to the country's independence.



The distinctiveness of cotton from Garo Hills lies in its remarkable durability, short fibers, and coarse texture. Presently, the Central Agriculture University (CAU) is placing considerable emphasis on conserving germplasm to safeguard the diversity of forthcoming crops. CAU is deeply involved in comprehensive research aimed at creating a high-yielding cotton variety. This endeavor is projected to extend over a span of 7 to 8 years, with its successful culmination holding the promise of substantially augmenting farmers' income.

### **ENTRY POINT ACTIVITY - COMMUNITY HALL**

The construction of 370 community halls has been sanctioned under EPA of MegLIFE. Initial phases of site preparation is underway.


