**MCLLMP****DISTRICT WISE ACTIVITIES****Two-Day Independence Day Celebration Ignites Tura's DC Park with Colors, Music and Commerce**

The Independence Day celebrations spanning two days commenced with a splendid display of pomp, colors, lights, music, and festivity at DC Park in Tura, West Garo Hills. The grand event brought together various entrepreneurs, agro-farmers, and artisans, all orchestrated by the collaborative efforts of organizations such as the Meghalaya Basin Management Agency (MBMA), District Commerce & Industries Centre (DCIC), PRIME Meghalaya, MSRLS, Meghalaya Grassroots Music Project-Tura, the Mini Bazaar, Chief Minister's Youth Centre (CMYC), and the Garo Hills Chess Association.

The inauguration of this magnificent event took place on the 14th of August at DC Park Tura. Shri Jadgeish Chelani, Deputy Commissioner of West Garo Hills, inaugurated the event, joined by Shri Abraham T. Sangma, Supt. of Police, West Garo Hills, and Smt. T.K. Sangma, ADC Tura. Various other officials from the District Administration and Line Departments were also present on this occasion.

## DISTRICT WISE ACTIVITIES

A diverse range of events and activities formed part of the two-day Independence Day Celebrations at DC Park, Tura. These included a flea market, exhibitions of visual arts and crafts, an entrepreneurs' meet, displays of handloom items and jewelry, children's games, food and beverage stalls, sit-and-paint sessions for children, a chess competition, and a music event. The festivities on August 14, 2023, were open to all citizens until 7 pm, inviting participation in the array of activities showcased across more than 45 stalls. Notably, the DPMU-CLLMP Team presented interactive stalls featuring 20 composting units for the 18th Days compost, around 30 saplings from CLLMP Nurseries, and 40 units of soda Karitchi by Shri Dharmen G Momin, a CLLMP Innovator, which garnered considerable interest and were sold during the event.

On the second day of the celebrations, August 15, the district administration organized numerous events at various locations. The central Independence Day celebration took place at Matchakolgre LP School field, followed by additional events at DC Park. Shri Thomas A. Sangma, Hon'ble Speaker of the Meghalaya Government & MLA-50 North Tura (ST), graced the occasion as the Chief Guest. This was accompanied by the presence of distinguished guests and invitees. The day's festivities at DC Park included live music performances, food stalls, a chess competition, and games for children, continuing until 9 pm. Concurrently, other events unfolded at the District Auditorium in Tura, offering a rich tapestry of celebrations for all to enjoy.

On August 10th, 2023, the accounts team visited Mawpun and Nongpyrdet villages, situated within the Bhoirymbong Block. This visit served a twofold objective. Firstly, it involved the preparation and collection of utility certificates as an integral part of the Forest Management Plan, aimed at ensuring the sustainable utilization of resources.

Secondly, the team worked on updating the village accounts book, a critical task contributing to the maintenance of financial transparency and accountability within these villages. This visit exemplifies a comprehensive endeavor towards the organized and responsible management of resources, finances, and developmental endeavors.



On August 9th, 2023, the EE-accounts team visited Saiden Village in the Umling Block with two main objectives: to create utility certificates aligned with the Forest Management Plan and to raise funds for the Excess Fund, encouraging responsible resource use. Additionally, during the visit, the team updated the village accounts book, meticulously recording all financial transactions.

**DISTRICT WISE ACTIVITIES**



On August 9th, Training Specialist and EE-Environment conducted a field visit to Mawtari Myrdon village in the Umsning Block. The objective was to gather data about the Forest Management Plan, specifically emphasizing the payment for ecosystem services concept. Throughout the visit, the team collected information on local forest resources, conservation efforts, and how these actions support ecosystem services.

The district GIS team visited Umsaw Nongkharai village in the Umling Block to gather data for planned activities falling under the concept of Payment for Ecosystem Services (PES). These activities encompass contour trenches, recharge ponds, loose boulder bunds, bench terracing, and headworks.



All these initiatives aim to conserve and enhance various ecosystem services by contributing to soil preservation, water management, and overall environmental sustainability. Implementing these measures can lead to improved soil fertility, increased water availability, reduced erosion, and better ecosystem health for the community or individuals. The collected GIS data will likely facilitate effective planning and design of these activities, tailored to the specific geographic and environmental conditions of Umsaw Nongkharai and its surroundings.

**DISTRICT WISE ACTIVITIES**



The District Project Manager, Ri Bhoi, conducted an assessment of the construction progress of a Natural Resource Management (NRM) library in Mawdiangum Village under Umling Block. Delays were noted during the inspection, attributed to valid reasons.

In response, DPM encouraged the VNRMC to accelerate construction efforts for the NRM library. The DPM likely stressed the timely completion of the library project due to its unique nature and potential benefits for the community.



**South West Khasi Hills**



Jakrem VNRMC started the community nursery on July 17th, 2020. The saplings in the nursery includes fruit trees like oranges, tangerines, peaches, plums, papayas, star fruits, and litchis. In 2023, matured saplings were sold: Cherry Blossom (30 x 1000 = 30,000), Apple (1 x 200 = 200), Kashmiri pine (15 x 30 = 450).

The Bolpuma village community is actively involved in improving agroforestry and fostering sapling growth. Collaborative efforts and proactive initiatives yield multiple advantages for both the environment and the local residents. Clearing weeds and trimming bushes enhances saplings' access to sunlight, nutrients, and water—essential for their robust development. Employing fencing safeguards the saplings from potential animal consumption, securing their survival and optimal progress. The villagers' collective endeavor underscores their commitment to the village's welfare and the preservation of its natural resources.



Dingrepa VNRMC has successfully established permanent nursery ensuring the growth of saplings inside the greenhouse. They selected a suitable site selection considering the sunlight, accessibility, and water availability. They collected native, climate-adapted seeds for community and reserve forest benefits.

## PAYMENT FOR ECOSYSTEM SERVICES

The graph below shows the total number of PES Scheme applications submitted on a block-by-block basis that are expected to be deployed for verification no later than the last week of August. Application forms for this batch were taken from 14 April until 12 August in addition to earlier batches or Phases. Overall, 1819 forms from the Khasi & Jaintia and Garo Regions have been gathered and are ready for verification.

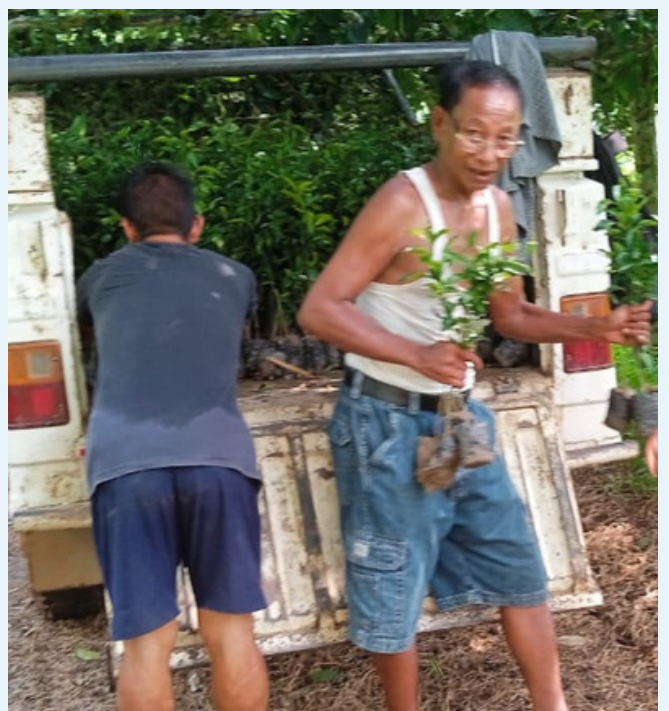

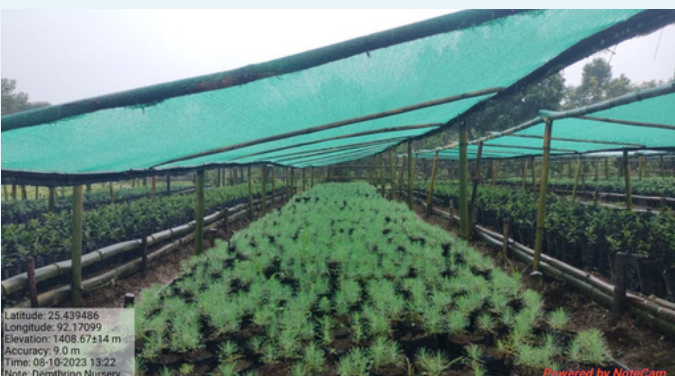

### Training on Skill Development on Primary Processing of essential oils and Management



A training on Skill Development on Primary Processing of essential oils and Management was carried out on 8th August, 2023. The training took place at Nongriangka village under Mawshynrut block, WKH which was led by the Bio-resource team. Farmers participating in the Mission actively engaged in a training programme, during which they gained practical knowledge in utilising a Field Distillation Unit for the extraction of essential oils. The training yielded positive outcomes as the farmers not only acquired hands-on experience but also had the opportunity to exchange their challenges and valuable insights with one another.



Director of INR, Shri L. Shabong, conducted a site inspection at Dympep, Synrangsohnoh, and Steplakrai villages situated in the Khatarshnong Laitkroh block, EKH. Throughout the inspection, the local farmers openly discussed their challenges and also shared a number of valuable findings regarding the cultivation of Medicinal and Aromatic Plants (MAPs). Notably, these MAPs were recognized for their positive impact on the environment, including carbon sequestration. The plants demonstrated the ability to absorb carbon dioxide and contribute to air purification.
